

Bids must be delivered to the address below on or before 15 March 2017 up to BST 15:00 hours (GMT+6 hours). Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on BST 15:30 hours (GMT +6:00 hours) on 15 March 2017 .
